TOURNAMENT RULES

1. **Certification:** This tournament is certified through the United States Bowling Congress (USBC). Rules not covered in this form are governed by the USBC rules and regulations.
2. **Eligibility:** Male and Female (excluding Youth) members of the Rowan/Mooresville USBC Association and USBC members from other associations who pay the association fee for Rowan/Mooresville USBC Association who have reached their 50th birthday by the tournament date are eligible to enter. NOTE: Bowlers from other associations will need to pay the local association fee of \$6.00 prior to bowling.
3. **Tournament Event:** The tournament shall consist of 3 Games, and shall consist of 2 bowlers, 1 male and 1 female.
4. **Entry Fees:** All fees must accompany entry. Entry fee is \$40.00 per bowler. Make all Checks or Money Orders payable to the ROWAN/MOORESVILLE USBC. Any check returned will be subject to a \$35 fee and paid before prize funds are distributed.

Fee Breakdown Per Event:
Lineage \$10.50 & Expenses: \$3.00
Prize fund: \$26.50

5. **Entering Average:** Bowlers entering average will be determined as described below:
 - a. The bowler's composite USBC average for the 2024/2025 season (based on a minimum of 21 games).
 - b. If no 24/25 composite average is available, a composite USBC Average from 2023/2024 can be used (21+ games).
 - c. If neither a nor b is available, the bowler's current 2025/2026 highest average with 21+ games may be used (**proof must be provided day of the tournament**)
 - d. If no yearbook average for a, b, or c can be provided, the bowler will enter with a 230 average.

NOTE: The 10-pin rule 319a-2 is not in effect

NOTE: It is each bowler's responsibility to determine that the submitted average is correct. Failure to use the correct average may result in disqualification.

6. **Tournament Schedule:** Event on Sunday, November 23, 2025, at 1:00 pm with check in starting at 12:00pm.

Note: No entries will be allowed the day of the Tournament.

7. **Handicap:** 90% of 230
8. **Reporting Prior Prize Winnings:** Refer to USBC rule 319d/2.
9. **Prize Money:** All Prize Money is returned 100%. Payout will be paid to one of every six entries. All prize money will be paid by individual checks and mailed to the team captain within 30 days after the close of the tournament unless a formal protest is filed with the R/M USBC. All checks must be cashed within 90 days from date of check
10. **Bowler Tardiness:** A late bowler will receive a zero for every frame missed. Missed frames cannot be made up.
11. **Pace:** When bowlers are scheduled alone on a pair of lanes, they must bowl as though they are contested. The bowlers complete one frame on one lane before the lead-off bowler starts the next frame on the adjoining lane.
12. **Protests:** Any protest affecting eligibility or general playing rules must be addressed with the Tournament Director before the prize payments are made. Errors in scoring must be reported to the Tournament Director immediately.
